YOU ARE FURTHER COMMANDED to serve a copy of such answer or

responsive pleading within said time period upon Franklin R. Harrison, Harrison, Sale, McCloy & Thompson, Post Office Drawer 1579, 304 Magnolia Avenue, Panama City, Florida 32402-1579, the attorney who filed the Petition for Final Order of Forfeiture.

B. Failure to file an answer or pleading within said time period shall result in the entry of a Default and Final Order of Forfeiture.

C. The Bay County Sheriff's Office shall retain possession of the 2002 SILVER IN COLOR FERRARI, VIN#: ZFFYT53A920129550 pending further order of this Court.

D. The Bay County Sheriff's Office shall return the 1971 GRUMMAN MODEL G-1159 FIXED WING JET, TAIL NO. N141JF, SERIAL NO. 106 to Aero Falcons, LLC by noon on May 22, 2003.
